Russ Jennings motioned to approve agenda, support by Lance Johnson. MOTION CARRIED.

All Boards approved the 2020-2021 Operational and Capital Budgets.

QUINCY FIRE ASSOCIATION FIRE TRUCK ACQUISITION AND OWNERSHIP AGREEMENT

THIS AGREEMENT is made and effective the	day of	, 2020 by and

WHEREAS the Village of Quincy, and the Towns compromise the members of the Quincy Fire Assexecution of the Quincy Fire Association Agreem	sociation which was for	med by

WHEREAS the Quincy Fire Association Agreement contemplates mutual ownership of assets and mutual responsibility for the costs of acquisition of fire equipment and fire department operations; and

WHEREAS recently, the need to acquire a new fire truck has been discussed by and between the constituent members of the Quincy Fire Association; and

WHEREAS a difference of opinion has arisen between the Village of Quincy and the Township of Quincy and the Township of Algansee wherein the Village of Quincy and the Township of Quincy believe that the acquisition of a new fire truck is necessary for continued effective operation of the Fire Association and the Township of Algansee does not agree and is unwilling to bear the expense of acquisition of said fire truck; and

WHEREAS the Village of Quincy and the Township of Quincy are willing to bear the expense of acquisition of the fire truck and allow the fire truck to be used by the Quincy Fire Association conditioned upon the continued ownership of the fire truck by the Township of Quincy and the Village of Quincy and further conditioned upon the Association being responsible for the costs of operation, repair, and maintenance of said fire truck; and

WHEREAS the parties to this Agreement wish to set forth the responsibilities regarding ownership of the new fire truck, responsibility for costs associated with operating, maintaining, and repairing the fire truck, and the right of the Township of Quincy and the Village of Quincy to retain full ownership of the fire truck in the event of the dissolution of the Quincy Fire Association pursuant to the terms of the Quincy Fire Association Agreement.

NOW THEREFORE, in consideration of the foregoing premises as well as the rights duties and obligations set forth below, the parties agree as follows:

The Village of Quincy and the Township of Quincy agree, at their sole expense, to purchase one (1) Pierce Manufacturing Side Mount Rescue Pumper mounted on a Pierce Manufacturing Enforcer Custom Chassis at a total cost of \$666,477.00. The VIN or other identifying number of the vehicle is 4P1BAAFF0LA021086.

The parties further agree that the above described fire truck may be used by the Quincy Fire Association and that the Association shall be responsible for expenses associated with maintaining said fire truck including costs of operations, routine maintenance, and repairs, but that the Association and its constituent units shall not be proportionately responsible for the payment of the acquisition cost of the fire truck. For purposes of this Agreement, "routine maintenance" and "repairs" shall be defined as the normal and usual repair and replacement necessary only as a result of periodic inspections and/or normal wear and tear. The Township of Quincy and Village of Quincy shall be solely responsible for any and all other maintenance and repairs of the above described fire truck.

The parties further agree that the allowance by the Township of Quincy and the Village of Quincy for the use of the fire truck by the Quincy Fire Association shall not be a release of their respective ownership interests in the truck and that, in the event of dissolution of the Quincy Fire Association pursuant to the terms of the Quincy Fire Association Agreement, ownership of the fire truck apparatus described herein shall be retained by the Township of Quincy and the Village of Quincy free of any and all claims of the Township of Algansee and that the value of said fire truck apparatus shall not be utilized in determining the proportionate financial interests of the respective members of the Fire Association in determining shares to be distributed in the event of a dissolution of the Fire Association.

The parties further agree that other than the matters addressed herein, this Agreement does not alter any of the other rights, duties, and responsibilities of the parties pursuant to the Quincy Fire Association Agreement and that except as stated herein, said Agreement remains in full force and effect.

The governing bodies of all of the constituent members of the Quincy Fire Association have authorized the individuals designated below to execute this Agreement.
