# QUINCY FIRE ASSOCIATION AGREEMENT

**THIS AGREEMENT** is made effective the \_\_\_\_\_ day of \_\_\_\_\_, 2024, by and among the VILLAGE OF QUINCY, a Michigan Municipal Corporation, of 47 Cole Street, Quincy MI 49082; the TOWNSHIP OF QUINCY, a Michigan Township, of 11 N. Main Street, Quincy MI 49082; the TOWNSHIP OF ALGANSEE, a Michigan Township, of 378 S. Ray-Quincy Rd, Quincy MI 49082.

**WHEREAS**, the parties are local governmental units located in Branch County, Michigan; and

**WHEREAS**, the parties have entered into various agreements, the most recent of which is dated April 1, 1998, for the provision of fire protection services within their territorial boundaries ("the Prior Agreement"); and

**WHEREAS**, the expenses for such fire protections have been shared as provided in the Prior Agreement; and

**WHEREAS**, the parties hereto own, through the Association, the premises located at 39 East Chicago Street, Quincy Michigan, which is more particularly described on Exhibit A attached hereto ("the Premises") for the purpose of housing the Quincy Fire Department and the fire apparatus and equipment heretofore utilized for fire protection; and

**WHEREAS**, the prior Agreement purportedly was established pursuant to Act 33 of the Public Acts of 1951, as amended ("Act 33"), but the Prior Agreement did not, in many respects, conform to the requirements of Act 33; and

**WHEREAS**, the parties wish to establish a separate entity for the provision of fire protection and rescue services, but Act 33 does not provide for the creation of separate entity; and

**WHEREAS**, the Urban Cooperation Act, being Act 7 of the Public Acts of 1967, extra session, as amended ("Act 7") permits local governmental units, including townships and villages, to establish a separate legal entity to exercise jointly any power, privilege or authority which each may exercise separately; and

**WHEREAS**, Act 3 of the Public Acts of 1895, as amended, authorizes the village to establish a fire department for the provision of fire protection; and

**WHEREAS**, Act 33 authorizes the townships to provide fire protection services; and

**WHEREAS**, the parties wish to establish the Quincy Fire Association as a separate entity to provide fire protection and rescue services within the geographical boundaries of the village and the townships.

**NOW, THEREFORE**, in consideration of the foregoing and of the mutual promises and covenants contained herein, the parties agree as follows:

## **ARTICLE I NAME AND STATUS**

There is hereby established Quincy Fire Association, (hereinafter referred to as the “Association”) which shall possess all of the powers granted joint fire administrative boards pursuant to Act 33, and which shall be a public body corporate pursuant to Section 7 of Act 7, being MCLA 124.507, MSA 5.4088(7). The Association shall not be operated for profit. No Part of its earnings shall inure to the benefit of a person other than the Constituent Units as defined herein.

## **ARTICLE II CONSTITUENT UNITS**

The local governmental units or public agencies creating the Quincy Fire Association are the VILLAGE OF QUINCY, the QUINCY TOWNSHIP, and the TOWNSHIP OF ALGANSEE, all located in Branch County Michigan (hereinafter collectively referred to as the “Constituent Units”)

## **ARTICLE III PURPOSE**

The purpose of the Association is to provide fire protection and rescue services within the territorial limits of the Constituent Units, and outside of said limits pursuant to Mutual Aid Agreements with other local governmental entities having fire departments. The name of the fire protection and rescue service established hereunder shall be the “Quincy Fire Department”

## **ARTICLE IV GOVERNING BODY**

- A. The Association shall be governed by a Board of Directors consisting of seven members, two of whom shall be appointed by the governing body of each Constituent Unit, which, as authorized by Article 7, Section 28 of the Michigan Constitution, may be members of the governing bodies of the Constituent Units. Pursuant to Section 11 of Act 33, at the first meeting of the Board, the Board shall by a resolution approved by a majority of its members select an additional member who shall be a resident of one of the Constituent Units and shall serve a two-year term. This member may be reappointed by a majority vote of the Board of Directors.
- B. Pursuant to Section 11 of Act 33, the members of the Board of Directors shall be appointed by their respective governing bodies for terms of four years.
- C. A member of the Board of Directors may be removed for misfeasance, malfeasance or nonfeasance in office or for any other reason deemed appropriate, by the appointing government body. A member who is not appointed by the governing body may be removed for misfeasance, malfeasance, or nonfeasance in office by a majority vote of the appointing authority.



- D. A vacancy in office created by resignation, removal or death shall be filled for the remainder of the unexpired term of office by appointment of the appointing authority within 60 days of the occurrence of the vacancy.
- E. Members of the Board appointed by a Constituent Unit shall be qualified electors of such Constituent Unit. A person in default to the Constituent Unit shall be ineligible to hold office, as shall be employees or volunteers of the Quincy Fire Association.
- F. Members of the Board may be compensated, in the discretion of the Board, for each meeting, not to exceed 52 meetings per year, at a rate not to exceed \$30 for each meeting a member attends. Any member shall be reimbursed for actual and necessary expenses incurred in the performance of his or her duties hereunder.

## **ARTICLE V OFFICERS**

At the first meeting of the Board, and subsequently at the annual meeting as herein provided, the Board shall elect a chairperson, vice-chairperson, secretary and a treasurer. The duties of the officers shall be as follows:

- A. Chairperson. The Chairperson shall be a member of the Board and shall preside at all meetings of the Board; shall countersign all the checks, drafts or disbursements from the funds of the Association; and shall have such other duties as may be assigned to him or her by the Board of Directors.
- B. Vice-Chairperson. The Vice-Chairperson shall be a member of the Board and shall preside at all meetings of the Board at which the Chairperson is absent; shall otherwise assume the duties of Chairperson in the absence or disability of the Chairperson; and shall have such other duties as may be assigned to him or her by the Board of Directors.
- C. Secretary. The Secretary shall be a member of the Board and shall attend all meetings of the Board and shall record or cause to be recorded all votes of the Board and shall keep or cause to be kept minutes in accordance with Act 267 of the Public Acts of 1967, as amended, in a book to be kept for that purpose; shall give or cause to be given notice of all meetings in accordance with Act 267 of the Public Acts of 1967, as amended; and shall perform such other duties as may be assigned to him or her by the Board of Directors.
- D. Treasurer. The Treasurer shall be a member of the Board and shall have the custody of the Association's funds; shall keep full and accurate accounts of receipts and disbursements of the funds of the Association in books and accounts in accordance with the Michigan uniform Budget and Accounting Act; shall deposit all monies in the name and to the credit of the Association in such depositories that may be designated by the Board of Directors. The Treasurer shall render to the board of Directors an account of his or her transactions as Treasurer and of the financial condition of the Association at every regular meeting of the Board and at such other times as the Board may direct. The Treasurer shall have such other duties as may be assigned to him or her by the Board of Directors. The Treasurer shall give such bond as shall be required by the Board of Directors.
- E. Assistant Secretary / Treasurer. The Board, upon the request of the Secretary and / or Treasurer, or upon its own initiative, may appoint an Assistant Secretary and / or Assistant Treasurer, who need not be members of the Board, to assist the Secretary and Treasurer respectively and to perform such duties as the Board may prescribe.

- F. Fire Chief. The Board shall appoint a Fire Chief, who shall not be a member of the Board but who shall attend all meetings of the Board unless such attendance is excused by the Board for good cause shown. The Chief shall be the Chief Administrative Officer of the Quincy Fire Department. The chief shall be accountable to the Board for the efficient and effective operation of the Quincy Fire Department, and for the Fire Department's compliance with all state laws and constituent unit ordinances. The Chief shall serve at the pleasure of the Board. The Chief, subject to the approval of the Board, shall appoint such Deputy Chiefs, Fire Captains, Lieutenants, and firefighters as the chief, with the approval of the Board, deems necessary to provide fire protection and rescue services. The Chief, subject to the approval of the Board, shall develop written administrative and personnel rules, including rules prescribing the qualifications and training for the Fire Department personnel. Except as authorized by the Chief or the Chief's designee, no person shall be permitted to perform fire protection and rescue services on behalf of the Quincy Fire Department.

## **ARTICLE VI MEETING AND RECORDS**

- A. The Board of Directors shall hold no less than six regular bimonthly meetings per year. Special meeting shall be called upon three days written notice, by the Chairperson or any two Board members.
- B. All meetings of the Board of Directors shall be held in compliance with the open Meetings Act, being Act 267 of the Public Acts of 1976, as amended. Public notice of the time, date and place of the meeting shall be given in the manner provided by the Open Meetings Act.
- C. A majority of the Board shall be a quorum for the transaction of business. A majority of all members of the Board is necessary for the adoption of a motion or a resolution.
- D. The Board of Directors shall adopt its own rules and procedure and shall keep a record of its proceedings. Records of the Board and of the Association are public records, which shall be made available to the public in compliance with the Freedom of Information Act, act 442 of the public acts of 1976, as amended.

## **ARTICLE VII POWERS**

The Association shall have all the powers given to joint fire administrative boards pursuant to Act 33, including but not limited to, and in addition thereto, the following powers:

- A. To acquire, maintain and dispose of, in its own name real property, and tangible and intangible personal property;
- B. To accept gifts and donations of money, real property, tangible and intangible personal property, and services;
- C. To apply for and accept grants from any source the Board deems appropriate;
- D. To receive appropriations and transfers of real and personal property from the Constituent Units;
- E. To sue or be sued in its own name;

- F. To make and enter into contracts, including contracts with Constituent Units;
- G. To employ agencies and employees;
- H. To engage the services of accountants, attorneys and such other persons as the Board deems appropriate to carry out its powers and duties;
- I. To incur debts and liabilities, subject to the approval of the governing bodies of the Constituent Units, provided however, such debts or liabilities shall not become debts or liabilities of the Constituent Units without the express written consent of the Constituent Units;
- J. To adopt rules, regulations, and procedures governing the operation of the Quincy Fire Department;
- K. To insure its property and its directors, officers, employees and agents;
- L. Subject to the approval of governing bodies of the Constituent Units, charge and collect fees for the fire protection and rescue services hereunder;
- M. To do all things necessary to fully carry out the purposes specified in Article III above.

## **ARTICLE VIII FINANCE AND BUDGET**

- A. The fiscal year of the Association shall end on the 31<sup>st</sup> day of March each year.
- B. The budget, accounts and financial affairs of the Association shall be in accordance with applicable state law.
- C. At the first meeting of the Board, the Board shall approve a proposed budget for the balance of the fiscal year, which budget shall be subject to the approval of the governing bodies of the Constituent Units.
- D. On or before the December meeting of each year, the Board shall approve a proposed budget for the next fiscal year, the budget shall be subject to the approval of the governing bodies of the Constituent Units.
- E. Each Constituent Unit shall appropriate its share of the projected expenditures for the Association's fiscal year as follows: The Constituent Unit shall be assessed a per capita assessment based on census data for each of the Constituent Units. The census data shall be adjusted every ten years after new census data is received. The Constituent Unit shall pay a proportion of the total budget, in which proportion the numerator is the number of residents in the Constituent unit, and the denominator is the total number of residents in all Constituent Units. The percentage share of each Constituent Unit shall be applicable not only for the annual budget, but for any purchases or expenditures for capital improvements. Any changes in proportional share shall take effect one year after adopted by the Association. The shares of the Constituent Units shall be reviewed annually not later than the December meeting, and may be adjusted for the next fiscal year by the board in its discretion.
- F. The appropriations of each Constituent Unit for each fiscal year shall be paid not less than quarterly.
- G. Penalty. In the event that any Constituent Unit refuses or fails to pay its share required under Article VIII (E), or any other provisions of this Agreement, a Constituent Unit may be removed from the Association by a majority vote of all Association members. In the event that a Constituent Unit is removed under this section of the Agreement, the Constituent Unit shall forfeit any and all interest in any property owned by the Association and shall not be entitled to any action against the Association for removal.

## **ARTICLE IX COMMITTEES**

The following committees shall be appointed by the Chairperson with the consent of the Board. The Board, by a 2/3 vote, may establish such additional committees as it deems to be proper for the carrying out of the business of the Association.

- A. Finance and Budget. The Finance and Budget Committee shall consist of three persons, one member shall be from each Constituent Unit and one of whom shall be the Treasurer of the Association. The Finance and Budget Committee shall prepare the proposed budget for the Association and shall have such other duties as the Board may from time to time prescribe.
- B. Personnel. The Personnel Committee shall consist of three members and shall have such duties as the board shall from time to time prescribe.
- C. Building and Equipment. The Building and Equipment Committee shall consist of three members, one from each Constituent unit, and shall have such duties as the Board may from time to time prescribe.

## **ARTICLE X AMENDMENT**

This Agreement may be amended, only upon the consent of all of the governing bodies of all of the Constituent Units, including but not limited to adding additional constituent units.

## **ARTICLE XI WITHDRAWAL OF A CONSTITUENT UNIT**

Any constituent unit may withdraw by giving written notice to the Board and the governing bodies of the remaining constituent units not less than one year prior to the beginning of a fiscal year. The withdrawal shall be effective on the first day of such fiscal year. The withdrawing constituent unit shall receive no reimbursement for any funds or property paid or contributed to the Quincy Fire Association. However, the withdrawing constituent unit shall pay all sums due from it to the Fire Association prior to the effective date of its withdrawal.

## **ARTICLE XII DISSOLUTION**

In the event that all Constituent Units of the Association shall agree, this Association may be dissolved by unanimous vote of the Association Board. In the event that there is a dissolution, all assets of the Association shall be sold within a reasonable time and all debts of the Association shall be paid. Any remaining funds shall be divided among the Constituent Association members, according to the, then effective, per capita population percentages.

## **ARTICLE XIII ARBITRATION**

In the event that there is a disagreement between Constituent Units and the Association, or any two or more Constituent Units, the subject of the disagreement may be submitted to arbitration.

The parties shall, at their option, choose the services of the American Arbitration Association, or, in the alternative, if the parties so agree, the parties may select an independent arbitrator who is either an attorney, or public official with experience in municipal government issues, and is not connected with the Association. The parties shall equally bear the cost of the arbitration, including all arbitration fees, except that each Constituent Unit or the Association shall bear the cost of its own representation at the arbitration.

#### **ARTICLE XIV MISCELLANEOUS**

This Agreement constitutes the entire agreement among the parties with respect to the matters dealt with herein. If any provision is found to be unenforceable or contrary to law by a court of competent jurisdiction, the remaining terms of the agreement, to the extent practical, shall remain in full force and effect.
