

## VILLAGE OF QUINCY DOWNTOWN DEVELOPMENT ASSOCIATION DEVELOPMENT AGREEMENT

The Village of Quincy Downtown Development Association ("Grantor") and \_\_\_\_\_ ("Grantee") hereby enter into this Development Agreement:

The basis for this Development Agreement is as follows:

1. The Quincy Downtown Development Association desires to promote the Quincy downtown area. In order to promote this, the Downtown Development Association works with various business owners and building owners to improve the visual qualities of the downtown area. In furtherance of that, the DDA has authorized matching grants for 50% of the qualifying amount for the exterior building renovation or remodeling, including signage affixed to the building (based upon Zoning Approval). The maximum qualifying amount of the grant shall be as follows: Roofs-25% of expenses, to a maximum reimbursement of \$1,000; Rear, front, and signs-50% of expenses, to a maximum reimbursement of \$4,000.00. Further, all remodeling and renovation must receive DDA approval prior to the commencement of the work.
2. The Quincy DDA will offer these matching grants for all improvements done and completed without accounts payable to the DDA or the Village of Quincy.
3. Disbursements of funds will be as follows: 25% of the qualifying amount (defined above) shall be disbursed upon the presentation and approval of the Downtown Development Association of the plans and estimate(s). The remaining 75% of the qualifying amount shall be disbursed upon the completion/proof of payment for the project. **PAYMENT WILL BE ISSUED TO THE PERSON APPLYING FOR THE GRANT.**
